

## Dr. John Humphreys

Dr. John Humphreys is Provost and Vice President for Academic Affairs at Texas A&M University – Commerce. He was formerly the Dean of the College of Business. His interests range from organizational leadership, strategy, and change, to managerial ethics and history. His work has appeared in numerous venues including the *Harvard Business Review*, *Human Relations*, *MIT Sloan Management Review*, *Thunderbird International Business Review*, *Business Horizons*, the *Journal of Management Inquiry*, *Management Decision*, the *Journal of Leadership & Organizational Studies*, *Leadership & Organizational Development Journal*, *Leadership*, the *Journal of Management History*, *Management & Organizational History*, the *Journal of Services Marketing*, the *Journal of Business and Management*, the *Journal of Applied Management and Entrepreneurship*, the *Journal of Business Strategy*, *Cross-Cultural Management*, *Industrial Management*, *BusinessWeek Online*, and *Measuring Business Excellence*. His work has been cited over 1,600 times in various articles and books, as well as the *New York Times*. The winner of numerous best paper awards, he is a four-time winner (2003, 2008, 2010, 2015) of the best paper on leadership given by the Management History division of the Academy of Management, a 2012 winner of the Halloran Award for the best paper on business ethics, and a 2015 winner of the *Journal of Management History* award for best paper with an international focus. Further, his scholarship has received outstanding article recognition by the *Journal of Applied Management and Entrepreneurship*, the *Journal of Management History* (twice), and the *Journal of eCommerce and Psychology*. In the international arena, Dr. Humphreys' primary expertise is China where he has served as a visiting professor at Shandong University (Jinan) and a Fulbright Scholar at Dongbei University of Finance and Economics (Dalian). He has also taught in Sarajevo, Bosnia and Herzegovina, Belgrade, Serbia, and Rabat, Morocco. In addition, he serves as a frequent reviewer for various publications and is an Editorial Board Member of *Thunderbird International Business Review*, *Management Decision*, the *Journal of Leadership & Organizational Studies*, the *Journal of Management History*, and the *Leadership & Organizational Development Journal*. Further, he is the current Co-Editor of the *Journal of Applied Management and Entrepreneurship*, and has served as Regional Editor (North America and Europe) for *Chinese Management Studies*, and as the division chair of the Management History division of the Academy of Management. He is a member of the Academy of Management, the American Psychological Association, the Society of Industrial and Organizational Psychologists, Phi Kappa Phi Honor Society, Beta Gamma Sigma Honor Society for Collegiate Schools of Business, Delta Mu Delta National Business Honor Society, and the Sigma Beta Delta International Honor Society for business, management, and administration. Prior to joining academia, Dr. Humphreys held a leadership position with a multi-billion dollar financial services organization.
