 Recent declining enrollment (Graduate and international) Graduate recruiter to be hired in each college, ad to be posted and hired by January, Marketing communications advertising through social media, Korean art display next week
 - b) ADC (Chip)
 Lifelong learning conference in Dallas, \$4500 being raised for a sponsorship (booth, discounts on faculty registrations), each college being asked to contribute \$200, wording on graduate recruiter, international recruiting
 - c) BRDC (Grady) 1st meeting of BRDC today, charge will be into 2 weeks, no tuition/fee increases per TAMUS, but...Differential tuition requests will be entertained (e.g. Nursing, Independent Studies), 12 semester Guaranteed Tuition plan will be mandatory (Chancellor) for all incoming undergraduates; COLA of \$200/semester allowed
 - d) Closing the Loop requests (final report) coming for CHEM and MATH for positions from last year's BRDC reallocation.
 - e) Discussion of using 1% reallocation to offset 3% enrollment shortfall, for this year, two possibilities 1) 1% internally (college), 2) 1% to pay off deficit from budget shortfall,

- enrollment 3% down on fall semester
- f) Reminder of note from Marshall on graduate assistant funding shortfall. Please resubmit any non-compliant requests to Lisa Owens. There is no extra money for additional GAs for Spring. Must use grants or IDC for any additional. GANTs/GARs need to come from IDC account.

Good Morning,

As you recall, funding from the Provost Office for GAs in the Fall 2013 semester was limited to 80% of requests. This was done in order to make sure that sufficient budgeted funds were in place to cover the needs for Spring. At the time, colleges were allowed to fund GAs from other sources to make up the difference.

However, due to the increase in the number of GATs (especially in the category of "GAT - not teacher of record") and GARs, the budget for tuition remission has been exceeded by an annualized amount of approximately \$120,000. That means that if we keep the number of qualifying GATs/GARs at the same level for Spring as what we had for Fall, we will need to come up with an additional \$120,000 in order to cover the tuition remission demands.

Funding from the Provost Office for the Spring semester GA needs will be about the same as it was for the Fall (these funds will be finalized and available by November 22). Therefore, due to the deficit in tuition remission funds, there should be no new GA positions filled for Spring. GA levels should not exceed the levels that we had for Fall, including the positions funded by the college/department.
