

## PSY 697: False Memory (Winter Mini 2012-13)

Recommended book: Publication Manual of the American Psychological Association (6<sup>th</sup> edition)

### Course Description

This course will provide you with the opportunity to learn about the basic theory and some applications of false memory research. For the first week, you will be introduced to several types and theories of false memory, and then you will choose a topic (from five options) on which to conduct your literature review. You will write a paper as a result of this process, and you will learn how to write it in proper APA (American Psychological Association) style, which is mandatory for manuscripts submitted for publication in the field of psychology.

### Readings and Discussion Posts

As you conduct your literature review, you will need to summarize two of the empirical articles you find and post each summary to the appropriate discussion board in eCollege. **The first summary is due by December 28<sup>th</sup>, and the second is due by January 4<sup>th</sup>.** You will also be required to read others' article summaries during these two weeks. This way, everyone in the class will get some exposure to each topic area being covered in each literature review. It will also help you to deeply digest at least two of the articles of your review, which no doubt will lead to a better ultimate paper.

### No Quizzes/Exams

There will be no formal quizzes or exams in this course, but there may be one or more exercises involving APA style.

### APA Style Training

During the first week of this course, you will receive several items that will educate you about current APA style writing requirements. These may include an exercise or two to assess your knowledge of APA style. The information will be very useful for the writing of your paper.

### Literature Review Paper

You need to conduct a literature review of a topic involving false memory. **By end of day on Friday December 21<sup>st</sup>**, you must select one topic from the following chapters (from *The Science of False Memory*, Brainerd & Reyna, 2005): (a) laboratory research with adults, (b) developmental research with children and adolescents, (c) adult interviewing and eyewitness identification, (d) child interviewing and testimony, and (e) false memory in psychotherapy. Once you choose the topic, I will send you the selected chapter. In reading the chapter, you will see citations of articles to include in your literature review. Your review will focus on a more specific topic from your selected chapter, but you won't know what this is until you read the chapter I send you. From that point

onward, you will work independently on your paper, being sure to post a summary of two of your articles to the discussion board (and also you should be reading others' posts; see above).

I will be happy to review a rough draft of your literature review, but it should be fairly complete before I see it. In other words, you should not send me a draft until all, or almost all, relevant articles have been read and integrated into the paper. I won't expect it to be "polished", but it should appear fairly complete in order for me to be able to give the best feedback for completion. Please email drafts to my email address listed above, and allow 48 hours for me to respond.

The final paper must be in current APA style (6<sup>th</sup> edition), and should reference approximately 10 readings (primarily empirical articles, but book chapters are acceptable). The paper should be approximately 10 pages in length, not including title page or references. No abstract is required. It is due by **midnight on the 9<sup>th</sup> of January**. The last class day of Winter Mini technically is the 7<sup>th</sup>, but I am extending your paper deadline beyond this a couple of days to give you a little extra time.

## Grading

Your grade will be based on the following: Discussion posts (20 points: 10 for each summary) and the paper (80 points).
