**COURSE DESCRIPTION**

Emphasis is on caring communication as an essential dimension of professional nursing. Theories are presented to explain the dynamic relationship between human behavior, health, and illness, and the impact of interpersonal relationship skills to effect positive changes in individuals and their families. Nurse communication in the role of educator will be introduced as part of the teaching/learning course content. (3 credit hours)

**Student Learning Outcomes:**

1. Relate the effects of perception, self-esteem, self-concept and body image on communication.
  - a. Define perception and its effect on communication.
  - b. Discuss the importance of defense mechanisms in perceptual distortions.
  - c. Differentiate between self-esteem, self-concept, and self-ideal.
  - d. Identify the effect of self-esteem and body image on communication and interpersonal relationships.
  - e. Relate the effect of defense mechanisms on communication.
2. Identify the relevance of caring to the practice of professional nursing.
  - a. Define caring.
  - b. Define empathy.
  - c. Identify purpose of therapeutic communication between nurse and client.

- d. Explain the relevance of self-esteem, self-concept, and insight to empathic and caring communications.
3. Describe the relationship of caring behaviors to each step of the nursing process.
  - a. Use facilitative caring behaviors to collect data.
  - b. Explain how problems/concerns are revealed through specific communication strategies.
4. Demonstrate therapeutic communication skills to affect positive changes in individuals from diverse populations.
5. Discuss the communication strategies for specific groups- families, children and the aged.
6. Demonstrate caring communication responses to common emotional behaviors.
  - a. Interpret patient behaviors used on the expanded knowledge of the emotional impact of illness- anger, anxiety, denial, and depression.
  - b. Identify strategies to manage conflict situations and reduce anger.
7. Demonstrate responsibility for own learning.
  - a. Select independent learning experiences related to own interests and needs.
  - b. Complete assignments within designated time period.
