**Course Description**

This course is an examination of the United States and Texas political systems with emphases on both formal and informal institutions and the roles they play in the creation and implementation of public policy. Topics considered include: the legislative, executive, and judicial branches; bureaucracies; and public policies. This course will also examine the historical, social, political, cultural, and international forces the effect our political systems in the United States and in Texas.

### **Student Learning Outcomes:**

1. Students will understand and employ significant theoretical and analytical approaches to explain the political institutions and policy development and implementation of the government of the United States.
2. Students will understand and employ significant theoretical and analytical approaches to explain the political institutions and state policy development and implementation of the state of Texas.

### **Attendance Policy**

Attendance will be taken daily, and you are expected to attend class regularly. A roll sheet will be provided during each class session; you are expected to keep track of signing in. If there is no signature on the class roll, you will not be given credit for attendance that day. Cheating will not be tolerated under any circumstances, so do not sign in for your neighbor. Anyone caught falsifying a roll call sheet will be reported under university guidelines for Academic Dishonesty.

Tardiness will not be tolerated. **The door will be closed after 10 minutes**; students arriving later will not be admitted and will be marked absent. Furthermore, if you must leave class for any reason, take your things with you as you will not be readmitted for class that day.

The attendance scale for this class is as follows:

- 1-3 absences – no penalty
- 4-5 absences – 2% reduction of final grade
- 6-7 absences – 5% reduction of final grade
- 8+ absences – failure of the course

Those who make it to the end without missing a single class will receive 5% on their overall exam grade.

**Quizzes cannot be made up.** If you are absent on the day a quiz is given, the grade will be zero. It is a small percentage of your grade, but it can make a difference. This is another important reason to make the effort to attend class.

**If you miss an exam:**

I understand that things happen in life that are unforeseen and beyond our control. To that end I will consider legitimate excuses for missing an exam, **only under extraordinary circumstances that made it impossible for you to attend.** In order to be considered for a make-up exam, you will be required to submit a request in writing, with supporting documents for your absence. Only one regular exam can be made up. **Make-up exams are comprehensive** and will be given during finals week.

**Exams:**

There will be three exams in this course. Together they will comprise 60% of your final grade. They are not comprehensive, and can be in any format including but not limited to multiple choice, short answers and essays. The format of each one will be given to you prior to that exam. **Tardiness for exams will not be tolerated. The classroom door will be locked at the beginning of class on exam days. Those arriving late will not be allowed in.**

**Camelot Simulation:**

*Camelot* is a role-playing simulation in which you will be introduced to participating in the process of local government through a series of city council meetings. The simulation will take place over a period of about three weeks, and each of you will be assigned to a role in the community of Camelot. A

successful simulation is entirely dependent on active participation. It can be an excellent learning experience if taken seriously, and most of all it can be a lot of fun if everyone plays their part. The goal is to provide you with a real-world understanding of the complexity and challenges in the political decision-making process, and to introduce you to the workings of city government.

There are three components to be graded during the simulation, worth a total of 30% of your final grade:

- Pre-simulation position paper – 10%: description of the role you will be playing and the philosophy of your character
- Post-simulation assessment paper – 10%: summary of your experience and what you learned through the process.
- Participation – 10%: presence in class is imperative during this time, and **more than one absence will result in a zero** for the participation grade.

As the semester progresses, handouts will be given with specifics for the written assignments and further details about the simulation.

### **Quizzes/Short Essays:**

Pop quizzes will periodically be given in class. These can be over the lectures, required reading, or current events. **Pop quizzes are by nature unannounced.** Various short essays may also be assigned throughout the semester at my discretion. Both quizzes and writing assignments will be graded on a scale of 10 points, and the average will comprise 10% of your final grade.

The percentage scale for final grades are as follows:

**A** 90-100%; **B** 80-90%; **C** 70-80%; **D** 60-70%; **F** Below 60%

### **Technology Policies**
