An interesting and challenging job serving as an educational resource for adults and youth, regarding all aspects of the livestock industry, while best utilizing my skills of livestock evaluation, critical thinking, and communication.

- Coached the Livestock Management Team that competed at the 2019 NACTA, Murray State University, Murray, KY. Team placed fourth, with 8th and 9th overall individuals.
- Have been very actively judging livestock shows and contacting Agriculture Educators, Extension Agents, and Junior College Livestock Judging Team Coaches, recruiting students interested in livestock and meats judging opportunities at Texas A&M University-Commerce.
- Serve on the Scholarship Committee and the Agriculture Banquet Committee.
 - Three round of scholarships were awarded for the 2018-2019 school year, totaling in excess of \$80,000.

 - 10th high beef individual in the Ak-sar-ben 4-H contest.
 - The National Western 4-H team was 12th overall and 11th in reasons.
- With the assistance of Dr. Travis Hoffman, ND/MN Extension Sheep Specialist, coordinated the purchase and transport of 16 market lambs, including the top 5, from the Sioux Empire Farm Show at Sioux Falls, SD. These lambs were used for livestock judging contests across North Dakota and Minnesota, while also providing tremendous educational value for numerous NDSU classes. Feedback from stakeholders, livestock judging contest participants, Extension Agents, and Agriculture Educators is excellent.
- Helped Dr. Hoffman conduct a Lambing Workshop at Tappen, ND, 60 participants. I conducted a one-hour, highly interactive session (morning and afternoon) on correcting abnormal lambing presentations, using a bovine pelvis and a stuffed animal, plus answered numerous lambing management questions. Compliments were tremendous and participants rated the session Outstanding.
- Assisted Dr. Leigh Ann Skurupey, ND 4-H Livestock and Equine Specialist, with conducting a livestock and equine judging oral reasons clinic, with 10 participants. Results from informal research conducted on lamb rearing, method of feeding hay, foot rot/foot scald treatment, lamb preference to form of creep feed, and more were communicated to key stakeholders.
