- 1) After conferring with the Department Head, faculty or staff member will complete section I of this form and send the form to the Dean of Graduate Studies, provide a copy to the faculty or staff member's department head/director, and academic dean/director of school preferably within ten (10) University business days of the discovery of the alleged violation. Complete a form for each student involved in the incident.
- 2) The Dean of Graduate Studies will verify if this allegation is the student's first or repeat offense. The Dean of Graduate Studies will then complete and sign Section II of this form, and return this form to the faculty/staff submitting this allegation.
