

# Instructions to complete the BSW SCHOOL Application for OF Admission

## Instructions

The BSW Application period opens on **Thursday**, **March 2**, **2023**, and **closes Wednesday**, **May 31st**, **2023** at **11:59 PM**. Please read the instructions carefully before completing the application at <u>BSW PROGRAM APPLICATION 2023</u>. This digital form has four labeled tabs:

- Application for Admission
- Code of Conduct for Social Work Students
- Reference Waiver
- Checklist

All the sections marked with asterisks (\*) within each tab are mandatory. You can move from tab to tab, by clicking on the corresponding tab at the top of the form or by clicking "NEXT" or "PREVIOUS" at the end of each page. The "SUBMIT" tool is at the end of the Checklist page. Please review all 7 pages of this document before you start to complete the application.

## Let's get Started!

#### I. Campus Preference

Select the Campus and schedule you are interested in attending. The schedule is set for students to take 2 face-to-face courses and 2 online courses for a total of four per semester. The cohorts starting in Fall 2023 will have the following options:

#### V. Demographic Information

This information is requested so that we can accurately report student demographic information to the Council on Social Work Education, and to help us with program planning. Your completion of this section, while not mandatory, will be greatly appreciated. You have the option to select *'prefer not to respond'* for each of these items.

#### VI. Educational Background

Indicate all institutions beyond high school that you have attended in the table provided in the application. Include these institutions in reverse chronological order, with the most recent listed first.

#### VII. Work Experiences

Indicate all employers that you have worked with in the table provided in the application. List the employers in reverse chronological order, with the most recent listed first.

#### VIII. Volunteering Experiences

Indicate all volunteering experiences you have had in the table provided in the application. List them in reverse chronological order, with the most recent listed first.

#### IX. Ability To Help Others

Social Work is a helping profession that requires a client-centered approach. Therefore, social workers must be willing to identify and address any challenges that may hinder their ability to professionally serve clients.

We would like to know if you understand that certain circumstances might affect the provision of services to the populations we serve. For example, populations you feel uncomfortable working with, establishing boundaries, etc. If you respond yes, be specific and explain it briefly (Max. 50 words) in the space provided.

Your response to this question will not influence your acceptance to the program. This information is requested to support and provide you with the tools necessary to succeed in this field.

#### X. Legal Information

Please respond to the items in this section.

If you respond yes to any of these questions, be specific and explain it briefly (Max. 50 words) in the space provided.

Your response to this question will not influence your acceptance to the program. This information is requested because it could impact your Field Practicum placement options. This will help us plan your internship path accordingly.

#### XI. Undergraduate Core and Prerequisite Courses

- 2. **Core courses:** Applicants should have completed 42 credit hours of core courses. These are included in the table on the application form. Use your

To be accepted to the program you must have passed with a grade of 'C' or better the following social work prerequisite courses:

## SWK 2361 SWK 2362 SWK 2389

If you have not taken SWK 2361, SWK 2362, and SWK 2389 before the start of the fall semester, you will not be accepted to the program. These courses will be offered during the summer session for those interested and applying for Fall 2023. Make sure to register for the courses needed for the summer session.

#### B. Other courses:

Ideally, to be accepted to the program you must have passed with a grade of 'C' or better the following prerequisite courses:

## MATH 1342 SOC 1306

If you have not taken MATH 1342 and SOC 1306 before the start of the fall semester, these courses will be included in your degree plan.

#### XII. Narrative

Please include a typed narrative of approximately 500 words in length in the space provided below. We recommend writing the narrative in a word document to facilitate the word count and copy-paste it below to avoid discrepancies. Please ensure to proofread for spelling and grammatical errors before you copy-paste the narrative.

The narrative should address the following:

- 1. Reasons you chose to pursue a career in social work
- 2. The field of social work practice you are interested in at this time
- 3. Personal characteristics and strengths that will contribute to success in social work
- 4. Personality aspects, knowledge, and/or skills that require improvement prior to beginning a professional social work career

#### XIII. Transcript

Attach current transcript, unofficial transcript, or advising report. (Current TAMUC students can attach their unofficial advising report from Degree Works).

#### XIV. Certification

Please sign the certification with your name, signature, and date.

#### XV. Code of Conduct

Please read and sign the Code of Conduct with your name and signature.

#### XVI. Reference waiver

Please complete and sign the reference waiver. It is **mandatory** that you submit the Reference Waiver to ensure your application is complete.

#### OTHER DOCUMENTS REQUIRED AS PART OF YOUR APPLICATION

#### **References (3)**

Request **TWO references from your college professors** and **ONE character reference** (employer, supervisor, organization leaders, or other faculty members). *References from family or friends will NOT be accepted*.

In case of any missing references, students will be informed in a timely manner to give them appropriate time to follow up or identify other References.

The Reference forms are due no later than **Wednesday**, **May 31st**, **2023**. Ensure you follow up with your potential references to ensure the timely submission of their reference forms.

## **Before you SUBMIT** (located at the end of the Checklist tab) ensure you have completed the following in the checklist:

- Completed all parts of this application and signed the certification
- □ Included the narrative in Section XII
- □ Attached current transcript, unofficial transcript, or advising report in section XIII
- Completed and signed the Reference Waiver within this application
- □ Signed the Code of Conduct within this application
